



- **R K Synthesis** is planning to take up new chemical manufacturing project in Gidc Industrial Estate, Vagra, Bharuch, Gujarat. The project involves manufacturing of chemical with capacity 2000 MT. The company has filed industrial entrepreneurs' memorandum on December 2019. As of March 2020, the project is in planning stage.
- **Guljag Industries** is planning to take up new diamino sulphanalide manufacturing project in Bhersam, Bharuch, Gujarat. The project involves manufacturing diamino sulphanalide with capacity of 3300 MT. The company has filed industrial entrepreneurs' memorandum on December 2019.
